- 3. Simply Driven Executive Cars Limited is a private hire licensed operator with South Derbyshire District Council. Where drivers are licensed under South Derbyshire District Council private hire drivers' conditions, they are bound by the conditions of the said licence.
- 4. Supporting operators are Licensed by their individual licensing authority and bound by said authorities licensing conditions.
- 5. Supporting Drivers are licensed under their individual Licensing authority's Driver's
- 6. Licence Conditions and represent their relative licensed operator.

General

- Customers will be charged for the travel booked, and route changes or additional pick up's and drop off destinations may incur extra charges.
 Additional travel is at the discretion of the driver and his schedule and availability for that day.
- Vehicles will only carry up to the licensed number of passengers which the hirer has designated and agreed with the Company, we will not carry more passengers than we are legally permitted to do so
- Whilst we do our utmost to ensure our drivers are punctual, you will understand that we cannot accept responsibility for delays caused by circumstances out of our control
- Every effort will be made by Simply Driven Executive Cars to ensure that our vehicle(s) or Sub- Contractors vehicle(s) arrive on time
- Your vehicle will travel by the most appropriate route on the day, unless instructed otherwise by the Customer at the time of booking
- The driver will drive at safe and sensible speeds in accordance with road conditions, traffic and the legal speed limits
- If there are any changes or variations including extra mileage on the journeys other than was agreed at the time of booking, the client will be charged extra in accordance with the pricing structure on our website

- We reserve the right to provide alternative vehicle(s) to carry out the hire in case of vehicle breakdown or other unforeseen problems arising, such as (but not limited to) delayed flight returns
- Simply Driven Executive Cars vehicles and sub-contracted vehicles are fully insured for passenger and third-party claims. However, customer's properties are carried entirely at their own risk and Simply Driven Executive Cars shall not be held responsible/liable for any loss/damage to such property
- Simply Driven Executive Cars will keep a lost property book at their office, and will endeavour to return any lost goods left in our vehicle(s) or subcontracted vehicle(s) to the customer
- Simply Driven Executive Cars drivers have the right to refuse to carry any
 passenger who is thought to be under the influence of alcohol or drugs and
 whose behaviour poses a threat either to the driver, the vehicle or any other
 passenger(s)
- Clients are responsible for any damage they may cause to the interior and or exterior of a vehicle on hire to them
- The client will be billed accordingly for any restorative repair or valeting required in order to reinstate a vehicle to the working order prior to hire for use.
- The Company' maintains a strict non-smoking policy in all its vehicles

Simply Driven Executive Cars Payment Terms & Conditions

Simply Driven Executive Cars offer a fair pricing policy on all of our engagements which we think represents good value for money. Please don't compare us with a standard Taxi service, although we may be slightly more expensive our service offers much more. We offer a bespoke executive and chauffeur car service and are not a regular private hire or taxi firm. We do not offer short "on the meter" type service and all prices are fixed and relayed before commencement.

Payments and Deposits

- All prices are calculated from Base to Base. This means that regardless of your collection point all journeys commence and finish in South Derbyshire.
- All monies are due 7 days before the date of your booking unless the travel is on account or agreed otherwise.
- Payment may be made by cash, Bacs, credit / debit card, cheque or pay pal.
 Details of how to pay will be forwarded via invoice with confirmation of booking
- Credit and Debit card payments are subject to a five (5) % surcharge for all cards issued abroad.
- Paypal Payments are subject to a five (5) % Surcharge
- A minimum fare of £45 applies for any single journey in the Mercedes E Class or V class
- If you book our Mercedes Chauffeur service we offer complimentary Meet and Greet Service*, waiting time and parking charges for the first hour after your flight has landed are included in the initial charge.
- 60 minutes waiting time is included in all airport transfers
- Waiting time is charged at £30 per hour or £7.50 per 15-minute period (or part thereof)
- Extras such as Toll Roads, London Congestion Charge etc will be charged at cost price unless agreed beforehand
- Without prejudice to the Company's rights hereunder all monies due to the company in respect of provision of the Services which are not paid by the due date for payment shall bear interest on the balance of such monies due from time to time at the rate of 3% per month until payment is received by the Company in respect thereof.

• It is a condition of this agreement that any invoices shall be paid in full within 7 days of issue thereof. If any invoices remain unpaid within 7 days such outstanding invoices shall immediately become due and payable.

Cancellation and Refund Policy

- If a booking is cancelled by the Customer within 48 hours from the start of the period of hire, 25% of all monies paid will be non-refundable.
- If a booking is cancelled by the Customer within 24 hours from the start of the period of hire, 50% of all monies paid will be non-refundable.
- If a booking is cancelled by the Customer within 12 hours from the start of the period of hire, 100% of all monies paid will be non-refundable.
- If the customer does not appear at the time and place designated as the pickup point, all monies paid will be non-refundable and client will be invoiced for full cost of booked travel

Driver Only Services

In response to client demand Simply Driven Executive Cars offer a driver only service where required by clients.

We aim to offer our quality trained chauffeurs to drive at the client's request.

We provide only fully licensed chauffeur drivers who are licensed and authorised by the local licensing authority pertaining to the chauffeur's locality. Simply Driven Executive Cars are licensed by South Derbyshire District Council.

We will:

- Complete a comprehensive inspection of the vehicle prior to journey advising of any imperfections in bodywork, paintwork, alloy wheels, internal seating, glass and any other defects that we feel appropriate to the vehicle.
- We will photograph and record all aspects of the vehicle in accordance with the general vehicle description contained within the Model system of vehicle examination
- Conduct a cursory check of tyre pressure, depth tread, service items connected to the safe driving of the vehicle
- Record details of vehicle mileage prior to commencement of journey
- Ensure sufficient fuel where appropriate for the journey all fuel costs remain the responsibility to the hirer
- Source appropriate "bolt on insurance to run alongside client's own insurance or request the hirer to provide comprehensive insurance cover for the duration of the journey
- Ensure that the shortest/most cost-effective route is taken to the destination and the minimal toll charges/costs are incurred.
- Should any deviation or route change be required consideration will be given to notifying the hirer of this if appropriate
- No use will be made of the vehicle other than the instruction of the hirer
- No non authorised passengers will be carried in the vehicle other that co-drivers authorised and licenced in accordance with local authority regulations.
- At the conclusion of the journey a further inspection will be undertaken of the vehicle and any defects, marks or incidents en-route will be recorded and the hirer made aware of any damages incurred.

All insurance excess premiums will be paid by Simply Driven Executive Cars in the event of any accident

Any visible damage not recorded prior to the commencement of the journey will be the responsibility of Simply Driven Executive Cars and should this be discovered the responsibility for repair will be with Simply Driven Executive Cars

Simply Driven Executive Cars will not hold any responsibility for damage that cannot be seen by external/internal inspection.

Simply Driven Executive Cars will not be held responsible for any breakdown, repair or recovery charges in the event of mechanical defect during the journey.

Should this occur then we will ensure that the vehicle remains attended until recovery to a suitable repair service attend.

We will not charge any excess charges for delays during the journey due to unforeseen circumstances, road closures, traffic delay.

Simply Driven Executive Cars will ensure that at the commencement of journey the vehicle is handed to a nominated person or parked in accordance with the directions and instructions of the owner.

We will provide full contact details of the chauffeur whilst en-route. Mobile telephone calls / texts will not be answered during a journey and a response will be made at the next safe point to stop.

Mobile telephones will be securely stored in a position away from view of the driver and no usage will be made of such a device whilst travelling.

Exception to the above will be the usage of a mobile telephone as a satellite navigation device which will be pre-set and not touched whilst the vehicle is in motion

All our chauffeurs will be fully conversant with the controls and instruments of the vehicle they are driving and be able to operate all in a safe and competent manner prior to commencement of the journey.

We will ensure that the vehicle is left in a clean and tidy condition and no food or drink will be eaten inside the vehicle during the journey.

Every care will be taken of the vehicle during the hire period and only travel relevant to the instructed journey will be undertaken.

We are happy to answer any questions in writing prior to commencement of any hire period and provide full details of the chauffeur and driving history to the client.
